2. Hazard identification

Classification of the substance and mixture:

No need for classification according to GHS criteria for this product.

Label elements and precautionary statement:

The product does not require a hazard warning label in accordance with GHS criteria.

3. Composition/information on ingredients

Chemical natureAqueous dispersion based on: acrylic polymers

4. First-Aid Measures

General advice:

First aid personnel should pay attention to their own safety. Remove contaminated clothing.

If inhaled:

If difficulties occur after vapour/aerosol has been inhaled, remove to fresh air and seek medical attention.

Methods for cleaning up or taking up:

For small amounts: Pick up with inert absorbent material (e.g. sand, earth etc.). Dispose of contaminated material as prescribed.

For large amounts: Pump off product.

7. Handling and Storage

Handling

Avoid aerosol formation. Avoid inhalation of mists/vapours. Avoid skin contact. No special measures necessary provided product is used correctly.

Storage

Suitable materials for containers: tin (tinplate)

Further information on storage conditions: Keep only in the original container in a cool, dry, well-ventilated place away from ignition sources, heat or flame. Store protected against freezing. Protect from direct sunlight.
